SUBJ: CY05 MUNITIONS SUPPORT SQUADRON (MUNSS) COMMANDER'S CANDIDATE SELECTION BOARD (MCCSB) (SUSPENSE: 11 JUN 04)

1. HQ USAFE IS PROUD TO ANNOUNCE THE CY05 MCCSB WILL CONVENE ON 29 JUN 04 IN THE HQ USAFE A4 CONFERENCE ROOM. OUR GOAL IS TO SELECT THE BEST-QUALIFIED CANDIDATES TO FILL TWO PROJECTED MUNSS COMMANDER POSITIONS AND OTHER VACANCIES AS THEY OCCUR. ALL NON-RATED LT COLS AND LT COL SELECTS ARE ELIGIBLE TO APPLY. RATED AFSCS WILL NOT BE RELEASED TO NON-RATED POSITIONS DUE TO THE CURRENT INVENTORY SHORTAGE. THE MCCSB IS A USAFE UNIQUE PROCESS. CONSIDERATION AND/OR SELECTION BY THE MCCSB DOES NOT EXCLUDE VOLUNTEERS FROM ELIGIBILITY FOR PRIMARY COMMANDER BOARDS (I.E., LOGISTICS OR SECURITY).
2. USAFE'S FOUR MUNSS ARE GEOGRAPHICALLY SEPARATED UNITS THROUGHOUT EUROPE (ALL ACCOMPANIED). THEY ARE COLLOCATED ON NATO HOST-NATION WING AIR BASES, WITH MUNSS COMMANDERS SERVING AS TENANT COMMANDERS ON EACH RESPECTIVE HOST-NATION WING STAFF. EACH MUNSS IS AUTHORIZED APPROXIMATELY 125 MANPOWER BILLETS ACROSS SEVERAL DIFFERENT DISCIPLINES.
3. THE JOB OF A MUNSS COMMANDER UNDOUBTEDLY RANKS AMONG ONE OF THE MOST CHALLENGING. THE COMPLEXITY OF THE MISSION, GEOGRAPHICAL SEPARATION FROM THE PARENT SUPPORT WING AND DISTINCTION OF BEING THE SENIOR U.S. REPRESENTATIVE ON A HOST-NATION BASE ARE UNIQUE FOR A LIEUTENANT COLONEL. IN MANY WAYS, A MUNSS PRESENTS CHALLENGES SIMILAR TO THOSE ENCOUNTERED BY A MISSION SUPPORT GROUP COMMANDER. FOR THIS REASON, COMMAND POSITIONS ARE AFSC 30C0. DUE TO THE TIMING OF MUNSS COMMANDERS APPOINTMENTS, POSITIONS MAY NOT BE IMMEDIATELY AVAILABLE. IF SELECTED AS A CANDIDATE, OFFICERS MAY BE CONSIDERED TO FILL ANY VACANT MUNSS COMMANDER POSITION. ANTICIPATED OPENINGS FOR THE CY05 BOARD INCLUDE BUCHEL AB, GERMANY AND GHEDI AB, ITALY.
4. ALL MUNSS MANPOWER AUTHORIZATIONS (EXCEPT THE 2 INDEPENDENT MEDICAL TECHNICIANS) ARE CODED EITHER AS CONTROLLED OR CRITICAL POSITIONS UNDER THE PERSONNEL RELIABILITY PROGRAM (PRP). AS THE UNIT PRP CERTIFYING OFFICIAL, COMMANDERS ARE ALSO REQUIRED TO BE PRP CERTIFIED IN ACCORDANCE WITH AFI 36-2104.

MUNSS PERSONNEL CERTIFIED IN CRITICAL PRP POSITIONS REQUIRE CURRENT TOP SECRET/SINGLE SCOPE BACKGROUND INVESTIGATION (TS/SSBI) CLEARANCE. PERSONNEL IN CONTROLLED PRP POSITIONS MUST POSSESS A SECRET-NATIONAL AGENCY CHECK (NAC) CLEARANCE.

5. THE BOARD WILL CONSIDER THE FOLLOWING FACTORS:

A. TOTAL NUCLEAR EXPERIENCE.

B. PREVIOUS SUCCESS AS COMMANDER OR LEADER OF A LARGE, DIVERSE WORKFORCE.

C. USAFE NUCLEAR EXPERIENCE.

D. PRIMARY JOB EXPERIENCE (ANY AFSC EXCEPT RATED IS ELIGIBLE TO APPLY, HOWEVER EXPERIENCED LINE OFFICERS WITH CORE AFSC OF 21M/21A, 31P, OR 13S HAVE PRIORITY BECAUSE OF THE UNIQUE MUNSS MISSION).

E. SELF-MOTIVATION, DECISIVENESS AND LEADERSHIP QUALITIES.

6. MUNSS COMMANDER CANDIDATES MUST:

A. BE NOMINATED BY THEIR WING COMMANDER, WING COMMANDER-EQUIVALENT OR SENIOR AIR FORCE REPRESENTATIVE.

B. BE A LIEUTENANT COLONEL SELECT OR A LIEUTENANT COLONEL. NOTE: LIEUTENANT COLONELS IN THE PRIMARY ZONE TO COLONEL IN CY05 (OFFICERS WITH A DATE OF RANK TO LIEUTENANT COLONEL OF 1 JUN 00 - 31 MAY 01) AND DEFERRED LIEUTENANT COLONELS ARE NOT ELIGIBLE.

C. HAVE A RECORD OF SUSTAINED SUPERIOR PERFORMANCE.

D. HAVE 3 YEARS RETAINABILITY (I.E., NO ESTABLISHED OR REQUESTED DATE OF SEPARATION WITHIN 3 YEARS OF THE BOARD SELECTION DATE). AFPC REQUIRES 16 MONTHS TIME ON STATION (TOS) AS OF 31 DEC 04.

E. HAVE NO ACTIVE UIF.

F. OFFICERS SERVING JOINT TOURS MUST HAVE A MINIMUM OF 24 MONTHS SERVED AT THE START OF THE HIRING CYCLE (1 JAN 05).

G. CONTACT THEIR AFPC FUNCTIONAL MANAGER PRIOR TO APPLYING TO HQ USAFE AS A CANDIDATE.

H. HAVE NOT DECLINED WITH PREJUDICE DURING THE PREVIOUS COMMAND CANDIDATE SELECTION PROCESS FOR WHICH THEY WERE ELIGIBLE TO COMPETE.

7. DEVIATIONS TO THE ABOVE ELIGIBILITY CRITERIA WILL REQUIRE, AS A MINIMUM HQ USAFE/A4 APPROVAL.

8. SENIOR RATERS SHOULD USE THE FOLLOWING CRITERIA WHEN CONSIDERING NOMINEES:

A. FITNESS FOR IMMEDIATE COMMAND - EVALUATE A CANDIDATE'S SUITABILITY FOR COMMAND. SELECTED OFFICERS COULD ASSUME COMMAND WITHIN 6 MONTHS.

B. PROVEN LEADERSHIP ABILITY AND GROWTH POTENTIAL - REVIEW THE OFFICER'S PAST AND PRESENT DUTY PERFORMANCE TO DETERMINE IF HE OR SHE IS READY FOR

PROGRESSION TO ROLES OF GREATER RESPONSIBILITY.

C. BACKGROUND - CONSIDER THE OFFICER'S DIVERSITY, EXPERIENCE, RELATED DUTY AND GENERAL PROFESSIONAL MILITARY EDUCATION.

9. NOMINATION PROCEDURES:

A. ALL INTERESTED OFFICERS, WILL COMPLETE A MCCSB SPECIFIC STATEMENT OF INTENT PROVIDED AND THEN EMAIL IT TO THEIR SENIOR RATER OR DESIGNATED POC. (NOTE: SINCE THE "SENIOR RATER" FOR LT COLS IS OFTEN THE NAF/CC, THE NAF/CC MAY DELEGATE STATEMENT OF INTENT REVIEW TO THE OFFICER'S WING/CC IF DESIRED.) THE SOI TEMPLATE MAY BE OBTAINED FROM THE LOGISTICS OFFICER ASSIGNMENTS WEB PAGE ([HTTP://WWW.AFPC.RANDOLPH.AF.MIL/LOGISTIC/LOGISTIC.HTM](http://www.afpc.randolph.af.mil/logistic/logistic.htm)) BY SELECTING THE LINK FOR THE SOI (CY 05 SQD/CC STATEMENT OF INTENT <<http://www.afpc.randolph.af.mil/logistic/SQUADRON%20COMMANDER%20CANDIDATE%20STATEMENT%20OF%20INTENT.doc>>). APPLICANTS ARE ASKED TO CHECK ALL OTHER FUNCTIONAL AREAS THEY ARE ASKING TO BE CONSIDERED FOR COMMAND. AS THIS IS A MCCSB SPECIFIC SOI, IT WILL NOT BE FORWARDED TO OTHER FUNCTIONALS BUT RATHER BE USED TO DECONFLICT DURING THE APPOINTMENT TO COMMAND PROCESS. OFFICERS MUST BE RELEASED BY THEIR AFPC ASSIGNMENT TEAM TO BE CONSIDERED FOR SQUADRON COMMANDER POSITIONS OUTSIDE THEIR CORE AFSC. THE SOI MUST BE SIGNED BY THE APPLICANT NLT 11 JUN 04 AND ENDORSED/RECEIVED (MAIL, FAX, OR E-COPY ACCEPTED) AT HQ USAFE NLT 18 JUN 04.

B. SENIOR RATERS: THE EMAIL MUST ALSO CLEARLY COME FROM THE SENIOR RATER'S ORGANIZATION -- I.E., SENDING FROM THE EXECUTIVE OFFICER'S EMAIL ACCOUNT IS FINE, AS LONG AS THE SENIOR RATER'S EMAIL ACCOUNT IS COURTESY COPIED.

C. COMMAND RECORDS:

(1) FOR NOMINEES NOT ASSIGNED TO USAFE--COPIES OF THE NOMINEE'S RECORD OF PERFORMANCE (ROP) MUST ALSO BE FORWARDED. DO NOT SEND ORIGINALS, AS THE ROP'S WILL BE DESTROYED AFTER THE BOARD. FORWARD THE MCCSB SPECIFIC STATEMENT OF INTENT AND ROP TO HQ USAFE/A1AO, ATTN: SSGT RUFER, MUNSS COMMANDER BOARD, UNIT 3050 BOX 25, APO AE 09094-5025. 10. PLEASE ENSURE RECORDS ARE CURRENT. ENCOURAGE OFFICERS TO REVIEW THEIR OWN RECORDS. IF CURRENT JOB PERFORMANCE OR OTHER PERTINENT INFORMATION IS NOT DOCUMENTED IN CANDIDATE'S RECORD, THE NOMINEE MAY SUBMIT A SIGNED MEMORANDUM TO HQ USAFE/A1AO, ADDRESSED TO THE BOARD PRESIDENT (HQ USAFE/A4), FOR INCLUSION IN THEIR PACKAGE.
