# GLOBAL CONNECTIONS

## An International Roster of Prominent Non-Government Organizations Advocating Abolition, Containment, or Cleanup of Nuclear Weapons

In the summer of 1998, under the auspices of the Project for Participatory Democracy of the Tides Center, a group of U.S.-based national, regional, and local organizations working on nuclear weapons issues met in Washington, D.C. to consider next steps in their work. That meeting produced a consensus to pursue four initiatives: 1) support for a nuclear weapons de-alerting campaign; 2) a continued emphasis on the cleanup of nuclear wastes generated by the U.S. nuclear weapons complex; 3) a "generation to generation" inquiry into how and to what extent young people are attracted to organizations working on nuclear weapons issues; and 4) encouraging greater communication and cooperation among international NGOs in their work on nuclear weapons issues.

This special report is offered as a first step to improve communication among prominent NGOs internationally and should be considered "a work in progress." We do not attempt to create a roster of all NGOs working on nuclear weapons abolition, control, and/or cleanup. Rather, working with organizations and individuals in the United States and abroad we have tried to list the relatively strong, freestanding groups with significant advocacy commitments, and we have attempted to avoid listing government funded and influenced organizations. In addition to this roster itself, we have included several email messages in an Appendix to give a flavor of the quality of communication that contributed to the report.

In the case of U.S. groups no attempt was made to list the hundreds of groups identifying themselves as working on abolition, containment, or cleanup associated with nuclear weapons. Instead we have chosen a representative sample of prominent NGOs. We want to thank a variety of individuals (the primary ones are listed on the inside front cover) who have helped identify the groups described in this report. While this help has been invaluable, we take responsibility for the choice of organizations listed here. This should be seen as an initial effort. We welcome general comments and suggestions of other prominent organizations that we might have overlooked.

We are living in a time of great change, led by the communications revolution and economic globalism. While the nation-state remains strong, new forces are challenging its authority. More than a quarter-century ago major corporations began planning for this change. We now have enormously powerful multi-national corporations and rapid capital movements dramatically influencing state and international affairs.

In the field of human services there has long been a global concern for health issues, with coordinated international efforts to control or eradicate dread diseases. More recently we have witnessed greater coordination among environmental organizations, public, private, and non-profit, to link their concerns and efforts globally. Efforts to abolish land mines, while not universally accepted, have been a signal international effort and an excellent example of communication and commitment led by NGOs. International efforts to control population growth, championed by many NGOs, are also having a marked effect.

Unfortunately, anti-nuclear NGOs have made only a limited effort to communicate and organize internationally. With the exception of the U.S.-based initiative, Abolition 2000, there is no systematic international source or pathway for information sharing, identification of common priorities, or development of campaigns and initiatives. Coordinated action among NGOs will require leadership that values broader communication, and cooperation around strategic priorities. Only in this way can influence and power be built commensurate with other forces of globalization and the still-enormous power of nation-states.

The listings and brief descriptions of NGOs in this report are an effort to move a step toward more effective international communication and cooperation. Using the Internet, an enormous opportunity exists for these NGOs to "get acquainted." Exploration of common goals, strategic priorities, initiatives, and best practices is basic to effective cooperation. Representatives of NGOs working on nuclear issues traveling abroad are also urged to visit organizations of the kind described in this report.

Beyond this, where might we go? An eventual conference of leaders from organizations listed in this report is one possibility. With careful planning, such a meeting might serve as the basis for a new global effort among NGOs concerned with nuclear weapons issues, and it could establish ground rules for expansion beyond this initial group.

Finally, we direct this special report to funders as well as to activist NGOs. Many U.S.-based philanthropists remain focused on domestic priorities. In light of the communications revolution and a continuing march toward globalism, we urge support for fledgling efforts internationally among NGOs to help them cooperatively gather the strength needed to become more effective in the global community.

### **New Agenda Coalition:**

On 9 June 1998, in an unexpected independent initiative in the UN Conference on Disarmament (CD) the Foreign Ministers of Brazil, Egypt, Ireland, Mexico, New Zealand, Slovenia, South Africa and Sweden simultaneously launched a Joint Declaration entitled "Towards A Nuclear Weapon-Free World: The Need For A New Agenda." Known as the New Agenda Coalition (NAC), these eight courageous governments criticized both the NWS and the three nuclear-capable states of India, Israel, and Pakistan, and called on them all to agree to start work immediately on the practical steps and negotiations required for elimination.

The Collective's main objective: the abolition of nuclear weapons and 3 objectives as a high priority for 1999/2000.

1 - That the government should raise the "defence secret status" on the archives concerning atomic tests in Polynesia and their potential consequences on health and the environment.

In order to achieve this :

STOP ESSAIS, out of solidarity for the Polynesian victims of 30 years of nuclear colonialism, supports the demand of the Synod of the Evangelical Churches of Polynesia and of the NGO Hiti Tau, calling for the raising of the military secret status of the archives relating to atomic tests. The whole truth must be uncovered concerning the possible consequences of the tests on the former employees of the CEP and of the people of Polynesia so that they may, if necessary, obtain treatment and appropriate medical follow-up for their condition, and compensation. STOP ESSAIS supports the results of the inquiry made amongst former workers of the Centre d'expérimentations du Pacifique (CEP) supported by the Europe-Pacifique Network (ECSIEP) and the Ecumenical Council of Churches. The Collective undertakes to disseminate any information available concerning the damage to the environment caused by the 193 tests performed on the Moruroa and Fagataufa atolls, and the 17 tests conducted in the Sahara (Algeria).

2 - STOP ESSAIS condemns simulations and the construction, currently in progress, of the Megajoule laser, key element in the PALEN program (for laboratory tests) and is launching a campaign to obtain a moratorium on the financing of the Megajoule laser.

For this purpose :

STOP ESSAIS proposes to all members of its network to send, on a massive scale, protest postcards to the Prime Minister, and to the Member of Parliament for their constituency (the list of all MP's is available on demand) with the following text :

"The construction of the Megajoule laser is "liable to relaunch the arms race". This very costly program is made to produce thermonuclear explosions. During the completion of the Ligne d'Integration Laser (LIL), we call on you to suspend any decision concerning the construction of the Megajoule laser until 2001. It would be infinitely wasteful to commit several billion francs' worth of expenditure to this project without waiting for the lessons of the performance of the prototype. The scale of the expenditure involved for this program and its probable consequences at an international level, in the light of our country's need to respect its commitments as a signatory to the Non-Proliferation Treaty (NPT) and the Comprehensive nuclear Test Ban (CNTB) require you to exercise the utmost vigilance".

3 - STOP ESSAIS undertakes to take all steps in its power in order to remind decision-makers of the judgement of the International Court of Justice on the illegality of the threat and use of nuclear weapons.

To achieve this :

STOP ESSAIS regularly publishes in its bulletin and other publications articles commenting on the various legal, political and humanitarian aspects of this exceptional judgment. Nuclear weapons are in principle illegal... On 8th July 1996, the International Court of Justice of the Hague declared that in practically all cases the threat and use of nuclear weapons are contrary to the rules of international law applicable in armed conflicts, and this in all conceivable circumstances. The Collective will be tireless in calling on the French government to use its influence within international bodies in order to obtain very rapidly the signing of a Convention banning nuclear weapons.

STOP ESSAIS acts in co-operation with the "Abolition 2000" world network which brings together nearly 1,000 NGOs of all five continents working for a commitment from France and other nuclear powers to proceed, in stages, to the dismantling of their arsenals.

Dear Sami,

thank you for your kind message and excuse me for being late in answering your inquiry. I was away for a while and am just back in Berlin again.

Regarding your question on NGOs dealing with nuclear disarmament issues, I have to inform you that at the moment there are none in Korea. There is no academic institution or even a section in any institution devoted to working on nuclear disarmament. However, there are some people who put part of their time and resources on studying nuclear issues. The main reason for this situation is that "anti-nuclear" was interpreted as anti-US and therefore prohibited by the government. Even today some Koreans believe that the US nuclear weapons are necessary to deter a North Korean invasion. In Korea, being a divided nation and still at war with each other, even the environmental aspect of nuclear waste disposal is highly political. The situation is improving slowly, but the uncertain political situation makes it difficult to predict.

Being an overseas Korean I have been working in this field for many years without serious political consequences in Korea. With the political changes in South Korea through democratization starting 1988, I decided to work with like-minded people in Korea and urging them to participate in international efforts to eliminate nuclear weapons. To this end I set up the Korean Pugwash Group in 1997 and have gained some influential people including former prime ministers, generals, and ministers. I invited Sir Joseph Rotblat, founder of Pugwash, to Korea last year and he could convince many more people. I also published the Korean translation of the Pugwash monograph, *A Nuclear-Weapon-Free-World: Possible and Feasible?* This book has gained much attention and was read by many responsible people. It was chosen as one of the best books in 1998. The Korean Pugwash Group finally succeeded in establishing a think-tank this year, the Korea International Peace Research Institute (KIPRI), in order to advocate nuclear disarmament issues in Korea as well as to support international efforts to eliminate the weapons of mass destruction. We are organizing a Pugwash Workshops on nuclear issues to meet early next year in Seoul.

This is the situation in Korea and hope you are not too dissatisfied. If you want, you can contact me directly or Dr. Cheon who has been dealing with the issues for some time. Dr. Seong-Hoon Cheon, Korea Institute of National Unification, is the best known in Korea in this field. His email address is (dearseong@netsgo.net).
